

# Privacy Policy in relation to Regulation (EU) 2016/679 (GDPR)

## Basic information

## What personal data we process and retrieve

We only process these details: your first and last name, email, phone number, and employer's business. Personal information we obtain especially from you personally, from business meetings, from business cards, phone calls, electronic correspondence, registration on our web site, also from colleagues in your employment.

## Use of personal data

We use your personal information for:

- Providing information on important notices to our product (patches, new releases, etc.);
- providing information about the news in our offer;
- sending invitations to organized events (conferences, seminars, fairs, trainings, etc.);
- communicating with you in order to address your questions and requirements.

We will process your personal data for as long as your consent to the processing of personal data is not revoked on your behalf or other conditions of "Forgotten" (see below) are met.

## Provision of personal data

The data will be used for the above-mentioned use and processing only by our company and will not be passed on to any other processor, Third party. Without your consent, we will not provide your personal information to other persons unless such obligation arises from generally binding legal regulations.

## Rights relating to the processing of personal data

In connection with the processing of your personal data, you have:

- the right to clear, transparent and understandable information about how we use your personal information and what your rights are (this is also the case);
- the right of access to personal data and the provision of further information related to its processing from SAE - Automation, s.r.o.;
- the right to correct inaccurate or incomplete personal data;
- the right to be erased (so-called right to be forgotten) of your personal data, especially if:
  - no longer necessary for further processing;
  - you have revoked your consent to their processing;
  - you have objected to their processing;
  - ill-treated illegally;
  - or they must be deleted by law.
- the right to limit processing - in some cases we may store personal information, but we must not treat it in any way; these are the following:
  - if you compromise the accuracy of your personal information until we verify its accuracy;
  - if personal data is processed inappropriately but you do not wish to delete them and delete the place of erasure just to restrict processing;
  - we do not need your personal data, but you need the data for the purposes of your claims;
  - if you object to their processing for as long as we do not know whether our legitimate reasons outweigh your interests.
  - the right to obtain their personal data and transfer them to another service provider;
